Voting by Proxy

Proxy voting means that if you aren't able to cast your vote in person, you can have someone you trust cast your vote for you.

If you are unable to attend the polling station in person for reasons relating to your occupation, service or employment, and you only become aware of this **after 5pm**, **on the sixth working day before the poll**, you can apply to vote by emergency proxy (someone else voting on your behalf). You can apply up until **5pm on the day of the poll**.

This form should not be used if you have been retained in a hospital under Section 145 of the Mental Health Act 1983 in England and Wales or Section 329 of the Mental Health (Care and Treatment) (Scotland) Act 2013 in Scotland.

In Scotland you must be 16 or over on polling day to vote in local elections and elections to the Scottish Parliament. You must be 18 or over to vote in UK Parliament elections.

How do I apply to vote by Proxy?

- You must ask someone who is willing and capable to be your proxy and vote on your behalf.
- Unless you are registered to vote as a service voter, you must get an appropriate person to sign your application. See notes below for information on who can support your application.
- Make sure all sections of the form are completed and supply your date of birth and signature. This information is needed to prevent fraud. If you are unable to sign this form, please contact us.

If you are not already registered to vote, your application to register must have reached your Electoral Registration Office by **midnight**, **12 working days before the poll**.

Who can support my application?

• I'm self-employed, who can support my application?

A person aged 18 years or over who knows you and is not your spouse, civil partner, parent, grandparent, brother, sister, child or grandchild. They need to complete section 8 of the form.

In Scotland, at local elections and elections to the Scotlish Parliament, your supporter can also be a person aged 16 or 17 years old, who knows you and is not your spouse, civil partner, brother, sister, child or grandchild. They need to complete section 10 of the form.

· I'm employed, who can support my application?

Your employer or another authorised person at your workplace. They need to complete section 9 of the form.

• I am registered as a service voter, who can support my application?

If you are a member of the Armed Forces, a Crown Servant, a British Council employee, or the spouse of civil partner of one of the above, or in Scotland, the child of one of the above, you are registered as a service voter, you do not need support for your application.

. I am registered anonymously, who can support my application?

If you are registered as an anonymous elector you do not need support for your application.

What happens after I have returned this form?

- Your proxy must go to your polling station to vote on your behalf.
- You should let your proxy know how you want them to vote on your behalf, for example, which candidate, party or outcome.
- The elections team at your council will tell your proxy when and where to vote on your behalf.

Voting as proxy

A person can only be a proxy for close relatives and up to two other people at an election or referendum.

Close relatives are the spouse, civil partner, parent, grandparent, brother, sister, child or grandchild of the applicant.

The person you wish to appoint as your proxy can only act as proxy if they are 18 or over (16 or over in Scotland at local elections and elections to the Scottish Parliament) and they are (or will be) registered for that election or referendum.

Privacy Statement

We collect information under the legal basis of a task carried out in the public interest, as set out in the Representation of the People Act 1983 and related regulations. We will look after personal information securely and follow data protection legislation.

If you opted-out of the open register we will only use the information you give us for electoral purposes, including matching it against other sources of data to support the electoral register. We will not give personal information to anyone else, unless we have to by law. The law requires us to share your information with candidates, political parties and campaigners for democratic engagement purposes and credit reference agencies to check your identity when you apply for credit.

If you have <u>not</u> opted-out of the open register your name and address can be bought by anyone and used for lots of purposes, including direct marketing.
